Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations,2015, and in continuation to our letter dated 12<sup>th</sup> May,2020, we wish to inform you that the Company is complying with various directives issued by the State /Central Government/Municipal Authorities on outbreak of COVID-19 pandemic. We are submitting below a brief update on the operations of the Company:

The Company has resumed limited functions at all Construction sites.

We would like to further inform that our Registered office is located at Mumbai, Maharashtra, where the State Government had extended complete lockdown till May 31, 2020.Further State Government has given permission to start offices with 10% work strength from 8<sup>th</sup> June,2020 onwards.So we are evaluating the possibilities to reopen offices in lines with notifications passed by Government.

The construction activity has been affected due to various factors like unavailability of sufficient semi-skilled /unskilled labor, insufficient logistics of raw material, reduced productivity of man power because of restricted time slots permitted and many more.

Though we have retained Labors to comply with statutory requirements at our sites and are managing our construction sites with limited resources. We have put in place various measures on social distancing and precautionary hygiene practices for safety of workers employed in construction facilities and on-ground operations. The operations ,Sales/Collections of all projects of the Company has been impacted ,but we are ensuring the movement as per permissions granted by Government.

We further add that, the financial impact, if any ,isn't ascertainable at this stage. The Company's internal financial reporting and control are in no manner impacted by the pandemic.

The Company shall closely monitor the prevalent situation and take all necessary steps as may required from time to time. We shall furnish further updates in case of any material development or changes.
